Dear Colleagues,

In this past year, 100 percent of California community college districts and colleges participated in League educational programming. One hundred percent of our member colleges subscribed to our policies and procedures service offering board policy and administrative regulation templates and evidentiary source material. And since 1990 — when the League registered with the state as a public benefit corporation — 100 percent of CCC's districts (now 73) have been members of the League.

The aforementioned membership data influence our ability to maintain capacity to provide the advocacy, district services, professional learning, and convening opportunities for the largest and most diverse public confederation of locally-governed districts in the nation. One hundred percent district and college membership confers credibility and legitimacy to our lobbying efforts in Sacramento and Washington, D.C. It supports our ability to negotiate with publishers of library databases and other vendors, and it means that you, the district and college leaders throughout California, have access to the unparalleled diversity that is the California community colleges.

On behalf of your colleagues serving on the League's three boards, and the entire League staff, thank you for your continued membership and for your dedication and commitment to advancing the essential mission of the California community colleges.

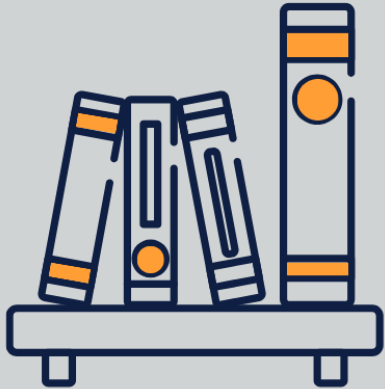

GOVERNMENT RELATIONS: INFLUENCING THE STATE AND NATION

The League's government relations team plays a crucial role in advocating for the interests and needs of community colleges across the state. Through their expertise in legislative analysis, they work closely with policymakers, legislators, and government agencies to shape public policy and secure vital funding, ensuring accessible and affordable education for California residents. The team builds coalitions, develops advocacy strategies, and effectively communicates the immense value of community colleges to government representatives, empowering individuals, transforming communities, and fostering a brighter future for California.

In addition to legislative efforts at the capital, the Government Relations Team also supports membership with ongoing advocacy information and trainings, including:

- The Legislative Conference, held each year, features high-level discussions surrounding hot-topic legislative issues and provides a unique opportunity for colleges and districts to engage with issue-area experts and state policy makers.
- Monthly webinars offer updates and insights on legislative matters statewide and federally, including answers to questions from our membership.
- Action alerts provide specific ways to advocate for legislation, including letter templates, contact details, and other advice to give colleges and districts a vehicle to have their voice heard on issues.
- Ongoing legislative visits, including trips to Washington D.C., office visits in Sacramento, and engagement opportunities at conferences, inform policy makers about issues that impact our 1.9 million students.

ADVOCATING FOR BACCALAUREATE DEGREE PROGRAMS

California community college baccalaureate degree programs (BDPs) offer Californians affordable, quality programs leading directly to in-demand jobs in thriving sectors of the economy. These degrees are significant for place-bound students or those living in education deserts where the nearest university may be hours away. These degrees are another example of California Community Colleges' responsiveness and student-centered focus.

The Community College League of California is committed to advocating on behalf of our member districts to increase these essential bachelor programs throughout the state. In 2022-23, the League supported colleges' and districts' efforts to increase their BDPs through advocacy, thought leadership, and dedicated resources.

- League President & CEO Larry A. Galizio authored opinion pieces about the importance of the BDP that captured more than 62 million readers in regional and higher education publications.
- The League hosted dedicated educational sessions about the BDP, including at the CEO Symposium and the Annual Trustees Conference.
- *Leading Community Colleges in California*, the League's podcast, featured Constance M. Carroll, Ph.D., Judy Miner, Ed.D., and Pamela T. Luster, Ed.D., California community college leaders who continue to advocate for baccalaureate degree programs for in-demand careers throughout the state.

HOUSING

Housing availability and affordability persist as issues for community college students. In the 2022-23 Fiscal Year, the League continued its advocacy for affordable, low-cost housing options for community college students.

Advocacy efforts, dedicated resources, and positive outcomes this year included:

- The CEO Affordability, Food, & Housing Access Taskforce report, "Deepening the Commitment to Affordable Student Housing," which addresses the growing issues with housing insecurity and lack of affordable housing for students.
- The League, along with partner organizations across the state, lobbied state legislators for full state funding of the Affordable Housing Grant when funding seemed tenuous in the 2023-24 budget cycle. The Governor and legislature reaffirmed state funding, ensuring that 12 projects that received construction grant funding in 2022 could proceed without risk to the districts.
- The League's Financing Authority issued Student Housing bonds for Napa Valley College's Rivertrail Village.
- Dedicated presentations on housing issues and needs at League conferences.
- Talking points, provided by the League's Government Relations team, reinforced the need for state funding to support affordable student housing.

EDUCATION SERVICES

The League's Education Services department curates professional development and events that support continued education for stakeholders across California's community colleges.

Four core programs provide interdisciplinary growth for Trustees and CEOs:

Effective Trusteeship Program: Trustees possess the tremendous responsibility of adapting their district's mission to community needs and ensuring college excellence and sustainability. Training and resources support trustees' depth of understanding about their duties, current issues, and emerging opportunities.

CEO Strategic Leadership Program: Chancellors, superintendent/presidents, and college presidents confront many challenges as the Chief Executive Officers (CEOs) at their district or college. The League provides leadership development and professional learning opportunities for current CEOs, as well as those aspiring to serve in the top administrative role.

First-Year Experience Program: As CEOs onboard into their new roles, they establish working relationships with their boards and staff, set vision and goals, and learn the unique qualities of their communities. This program, as part of the League on Call consulting, supports CEOs' smooth transition through mentorship, workshops, and training.

Aspiring CEO Program: The Aspiring CEO Program supports community college leaders as they prepare for CEO roles, guiding self-assessment and skill development needed for their next step.

Each year, the League hosts six educational events that feature topical plenary and concurrent sessions, as well as networking with statewide colleagues.

- **Effective Trusteeship Workshop:** Provides trustees the tools to continually deepen and expand their knowledge.
- **Board Chair Workshop:** Guides trustees who assume board leadership with chair-specific training and resources.
- **Legislative Conference:** Supports districts advocacy efforts with budget highlights, legislation updates, and training.
- **CEO Symposium:** Brings presidents, superintendent/presidents, and chancellors together for executive discussion.
- **Annual Trustees Conference:** Gathers statewide trustees for sessions designed specifically for board members' needs.
- **Student Trustees Workshop:** Introduces students to their roles, rights, responsibilities, and understanding of governance.
- **Annual Convention:** Gathers community college professionals from across the state to address systemwide topics.

Additionally, the League's Education Services hosts periodic webinars on emerging and essential topics for CEOs, trustees, and other community college leaders.

League volunteer committee members identify and review the educational and professional development programs offered to the colleges, particularly those targeted to CEOs and trustees.

DISTRICT SERVICES

The League's District Services bring direct-to-district programs that offer collaborative purchasing and competitive pricing. These centralized service options allow districts to leverage statewide buying power, access centralized information and resources, and stay current through ongoing educational programming.

Statewide Policy & Procedure Service

This uniquely aligned service reflects DEIA needs, addresses accessibility, and strengthens the roles of districts. The League's Policy & Procedure program provides language required for legal compliance and considers federal/state court cases, Attorney General opinions, and PERB rulings, providing the best assets for their clients. All 73 districts subscribe to this service, with access to more than 400 templates and implementation strategies.

Every area of institutional operations covered by the BPs/APs affects student, community, and employee access to districts' programs and services. The tools provided by the League's Policy & Procedures program prepare districts and campuses to make positive changes that:

- Draw the connection between that area's institutional function and relevant issues
- Create expectations and accountability
- Offer procedures to execute broad policies

This year, the Policy & Procedures program addressed mandated requirements regarding these topics, and more:

- Title IX compliance
- Student discipline
- Free speech
- Nondiscrimination
- Prohibition of harassment
- Family Educational Rights and Privacy Act

Library Consortium

One of the League's most utilized services is the Community College Library Consortium, a joint project with the Council of Chief Librarians. The Consortium provides informational databases and other vital online resources to libraries at all 116 colleges and many off-campus centers throughout California and beyond. The Consortium provides college librarians with information about all available consortium services as well as reviews on databases, information on how to order and renew subscriptions, usage statistics, and license agreements.

This past year, the Library Consortium provided systems supported and coordinated technology for all 110 colleges participating in the Library Services Platform (LSP) program. Additionally, the Library Consortium team hosted 27 synchronous weekly webinars featuring dynamic content with experts and vendors in the academic library field. Over 1,600 people attended these webinars.

More than 1,600 people attended Library Consortium webinars in the last year.

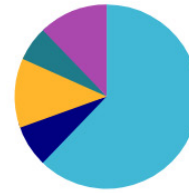

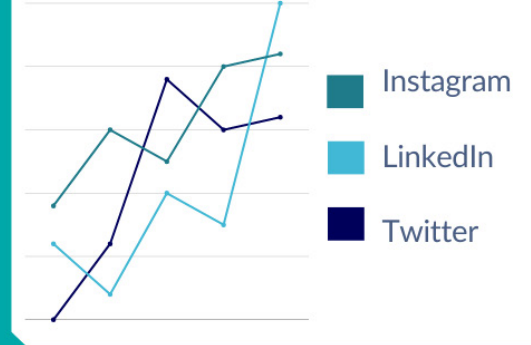
Who follows the League on social media?

FISCAL SERVICES

Every member organization interacts with the League's fiscal department, directly and peripherally, through dues, event registrations, and the distribution of League scholarships and sponsorships. As a centralized financial management hub, Fiscal Services is the organization's backbone, accounting for organizational expenses and income. More visibly, the department is the fiscal sponsor and fiscal agent for more than a dozen statewide community college groups, providing regular financial accounting, processing sponsorships and registrations, and assisting with organizational membership reports.

Fiscal Services also supports:

Sponsorships for important student and professional-facing programs such as Black Student Success Week, APAHE, and A2MEND.

Scholarships and student recognitions, including the purchase of Phi Theta Kappa honor cords for students each spring.

Fiscal Sponsor for two statewide organizations: the California Community College Athletic Association (3C2A), and the EDGE Coalition.

Fiscal Agent services for a dozen affinity groups and caucuses, including the African American Community College Trustees and Administrators Association; Asian American Pacific Islander Trustees & Administrators; Affordability, Food, & Housing Access Taskforce; California Association of Black School Educators; California Association of Latino Community College Trustees & Administrators; California Community Colleges Classified Senate; California Community College Baccalaureate Association; California Community Colleges Veterans Caucus; California Community College Women's Caucus; Community College Public Relations Organization; Equity Avengers; and the LGBTQ+ Caucus.

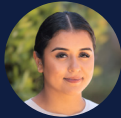
