- Define annual as "fiscal" year (July 1 to June 30 of the next year)
- Change name to add "California."
- Change name to replace "Association" with "Caucus."

Fiscal is to align with other caucuses so when CCLC has a common membership payment process, we could all be aligned and share the same cycle. Also, for all those colleges that paid this of 2024, their membership will count for the entire fiscal year of July 1, 2024 – June 30, 2025 – an effort to "grandfather/mother" in. "California" is to make ourselves distinct from the national Black Caucus as our California one is getting more national recognition. "Caucus" since we called ourselves as a Black Caucus, and the word "Association" adds an unnecessary letter to the acronym and Caucus is more appropriate.
